PROJECT SUMMARY

Harbor Care, Inc. was contracted to provide facilitating organization (FO) services for the 12 Recovery Community Organizations (RCOs) in NH that provide Peer Recovery Support Services (PRSS) to individuals with Substance Use Disorder (SUD) and their families. FO services include but are not limited to:

- > Provide funding and assistance for operational and programmatic support to each RCO.
- Support the provision of quality PRSS within each recovery center.
- Monitor each subcontractor's compliance through regularly occurring meetings.
- Subcontract with 12 RCOs totaling 19 open RCCs providing PRSS.
- > Ensure each subcontracted RCO provide a minimum of one recovery center, recovery coaching, telephone recovery support, a venue for mutual aid meetings, additional support as determined by the local community, engage with local and regional partners, and comply with all applicable state and federal laws, rules, and regulations.
- > Work to maintain existing recovery centers and establish new centers in underserved geographic regions.
- Work with each subcontractor within each centers' administrative capacity and readiness to reach the following goals; meet the Council on Accreditation of Peer Recovery Support Services (CAPRSS) standards, Medicaid enrollment and billing, capacity building, sustainability, and service development.
- Assist subcontractors with ongoing back-office functions as needed included but not limited to HR, IT, P&P development, grant writing, compliance monitoring, quality improvement, billing, and data collection and management.
- Ensure training and TA is available to recovery center staff including but not limited to recovery coaching, TRS, co-occurring disorders, family dynamics of addiction, ethical standards, information security, and HIPAA.
- > Facilitate a Community of Practice (CoP) that allows administrators and leaders to establish and strengthen cooperation, collaboration, and informal mentoring.
- Ensure RCOs are providing CRSWs with supervision in compliance with the NH Licensing Board.
- Implement data collections and organization process using RecoveryLink.
- > Collaborate with the Department to evaluate service performance and participant level outcomes and enhance contract management.
- Actively promote the availability, purpose, and value of PRSS across NH.
- Facilitate monthly RCO leadership meetings.

Service Delivery	 Currently we are supporting 98 participants through Comprehensive Recovery Coaching.
	 Currently we are supporting 25 participants through Telephone Recovery Support. All three centers host mutual aid meetings, AA and NA, with regular attendance averaging between 3 to 25 individuals per meeting.
	 Our agency continues to facilitate Parenting Journey in Recovery. We have two additional recovery coaches now trained to facilitate the group; now totaling 5 staff trained in facilitating this curriculum.
	This quarter we have provided 20 transports to reduce barriers such as making probation/parole check ins, successfully making medical/mental health appointments, as well as timely transportation to treatment.
	Our agency continues to collaborate with the local Federally Qualified Healthcare Clinic, Health First, with locations in Franklin, Tilton, and Laconia; towards providing effective wrap around services for participants engaged in Medication Assisted Treatment. Currently our agency is supporting 16 participants, that also receive MAT services through Health First.
Quarter Highlights	 Archways-Tilton facilitated an 8-week workshop; "The Power of Expression in Recovery: Journaling and Creative Arts Workshop" in which 9 individuals engaged and participated in this Hybrid offering. We received a lot of positive feedback from engaged individuals, and had very consistent participation. We are planning to run this workshop again in August 2022.
	 Two of our Recovery Coaches completed a six-week Nurturing Families in Recovery curriculum training, to be able to better support participants and their families.
	 Our organization was represented at a variety of community outreach events including Drug Take Back Day, Choose Franklin Community Day, Winni-River Day, and Tilton Old Home Day. Additional outreach continues to include targeted outreach to those experiencing homelessness, as well as those currently engaged in SUD treatment programs, in order to provide recovery supports.
	 Franklin and Tilton locations collaborated with the regional Partnership for Public Health Network to facilitate a pre and post survey to young adults, ages 18 to 25, focused on informative information regarding pregnancy and the use of alcohol or substances during pregnancy. Our organization delivered a total of 86 surveys!!
	The Concord center location assisted three individuals that had been experiencing homelessness find stable housing within a recovery home. This success and reduction of barriers can be seen as a result of our professional networking relationships, as it is common requirement for individuals to come directly from a
	 treatment program to enter into recovery homes. Our Recovery Supports team meets monthly, during which we routinely review required benchmarks including the percent of completed BARC-10 assessments. Staff has done an amazing job at setting their own benchmark for BARC-10 completion rates and not only meeting their goal but exceeding it! During this
	quarter, the percent of BARC10s completed, has started to reach nearly 50%!
Challenges	 We have found that there is not a lot of "foot traffic" happening around the Concord Center location, this may be somewhat of a challenge to increasing the number of participants served through this location.
	o We will be building the Concord Center location profile within the closed loop referral platform, Unite Us, as a way to be more visible to community
	partners, external providers, to allow for additional referral sources.

- Concord Center manager to continue attending monthly Capital Area Leadership Team meetings, prepared to share information about offered programs and services.
- Concord Center manager and staff will begin targeted outreach to local community partners, including the local Concord probation office.
- Continue receiving referrals from Concord Hospital's IOP program for recovery coaching services out of the Concord location.
- A collaboration with the Homeless Resource Center (HRC) is underway as the planning meetings were completed. The intent is to establish a weekly presence to engage with those interested in recovery who are experiencing homelessness and/or utilizing some of the HRC resources.
- We have been experiencing a challenge with how staff are utilizing their PTO benefit; balancing staff needs while still meeting our contract deliverables.
 - We will be meeting with our HR consultant to review our current PTO policy and work to include any revisions or additions that will decrease the frequency of this challenge.

Challenges

- Hope's biggest and most persistent challenge is the tension between our two roles: community organization and recovery center. Through our halls pass more than a thousand people weekly. Some come just for the more than 30 meetings per week we host. For others it's the chance to paint with quality supplies, create music with our keyboards, drums and stringed instruments. Some come to play that music for an audience, read their poetry aloud, juggle or perform stand-up comedy. Others come to have a safe and fun drug-free place to spend time playing chess or cards or simply talking with others. Coffee is always free and available, and we work hard to make the place open and welcoming. Hope is the kind of community center every city or town needs. We are proud of our accomplishments here.
- As a recovery center, Hope receives funding from the State of New Hampshire through the Facilitating Organization. As part of this process, we have obligations to provide data to demonstrate we are doing the things for which we are being

- paid. In this, we do an acceptable job, but data collection and community building are strange bedfellows.
- Like the illustration above, Hope is two things, depending upon where one's focus lies. While it may be possible to simultaneously perceive two faces looking at each other at the same time one sees a goblet, most of us need to consciously shift back and forth. Thus, it is with Hope's challenge. We are both a community center, with human beings looking into one another's eyes and a recovery center, with inanimate data as a goal. This balancing act is the challenge, with perfect equilibrium our never-to-be-met goal.

Service Delivery	 PRSS & TRS: The primary service we offer to participants is one-on-one peer supports, either in person or over the phone. PRSS & TRS includes brief check-ins, follow-up engagements, helping participants achieve goals set in their recovery wellness plans, and providing case management/system navigation. Homelessness Outreach: Three days a week the coaches go out in pairs to provide street outreach to people experiencing homelessness. Coaches offer treatment and recovery resources, hand out tents, blankets, socks, naloxone, etc., and provide PPE, rapid COVID tests, and vaccine information. Since June 2021 we have made 522 contacts, with 109 in this past quarter. Compass House: We continue to provide weekly house meetings and one-on-one coaching to the women at Compass House. CORE Groups: Weekly group meetings are held at Belknap County Corrections for the residents in the Correctional Opportunity for Recovery and Education Program. 24/7 Hospital Support: This quarter we saw 60 patients in the hospital and referred patients to withdrawal management, treatment (all levels of care), sober living, group meetings, The Doorway, and peer support services. Parenting Journey in Recovery: Weeks 2-12 were held this quarter with 7 attendees. Pro-social activities: This quarter we introduced a hiking group that meets every Saturday morning. So far they have hiked Lockes Hill, Mount Rowe, Belknap Mountain, Mount Major, South Piper, and Mount Shannon.
Quarter Highlights	 Male participant reached his 18-month anniversary and joined our Advisory Council. Male participant reached his 10-month anniversary, bought a new motorcycle, and has the best family relations he's had since he began using substances.
