Definitions

- **Digital Recovery Support Services (DRSS):** PRSS services that are provided through online or telephonic platforms in lieu of face to face contact.
- Peer Recovery Support Services (PRSS): Social support designed and delivered by people who have experienced Substance Used Disorder and recovery. This peer-based model helps individuals engage in the recovery process and embodies a message of hope for the recovering community (SAHMSA, 2009).
- Recovery: a process of change through which people improve their health and wellness, live self-directed lives, and strive to reach their full potential (SAMHSA, 2020). There are four major dimensions that support recovery:
 - **Health**—overcoming or managing one's disease(s) or symptoms and making informed, healthy choices that support physical and emotional well-being.
 - o **Home**—having a stable and safe place to live.
 - Purpose—conducting meaningful daily activities and having the independence, income, and resources to participate in society.
 - Community—having relationships and social networks that provide support, friendship, love, and hope.
- Recovery Capital: Conceptually linked to protective factors and wellness, Recovery Capital can be divided into three categories; personal, family or social and community. These categories encompass factors such as physical health, basic needs, social relationships, attitudes, policies, and other resources (W. White, W. Cloud, 2008). Recovery Capital is measured through the Brief Assessment in Recovery Capital (BARC-10) assessment tool on a scale of 10-60.
- Recovery Coaching (RC): One-to-one mentoring wherein focus is to work with the service recipient in development and accountability with a personal Recovery Wellness Plan. Help with barrier reduction and systems navigation is also expected. Relationship is ongoing until terminated by either party.
- Recovery Community Center (RCC): Peer operated centers that serve as local resources of community-based recovery support and help build recovery capital among individuals and the community (Recovery Research Institute). A single Recovery Community Organization can have multiple centers.
- Recovery Community Organization (RCO): "An independent, non-profit organization led and governed by representatives of local communities of recovery. These organizations organize recovery-focused policy advocacy activities, carry out recovery-focused community education and outreach programs, and/or provide peer-based recovery support services" (P. Valentine, W. White, P. Taylor, 2007).
- **Telephone Recovery Support (TRS):** Weekly outgoing calls to individuals for brief check-ins on his/her/their status and progress in recovery. Referral to other resources is expected. Relationship usually lasts the length of each call, with multiple RCO representatives calling daily lists of program participants.
- Activities/Activity Logs: Group services that can cover a variety of topics. Some common group activities that
 RCOs host are anonymous step groups, family support groups, art, music, and writing groups, yoga, and mutual
 aid meetings. RCOs are also able to track any trainings or outreach they offer to the public or their local
 communities.
- Brief check ins: are used to record Telephone Recovery Support service engagements in RecoveryLink. These
 engagements typically last less than 15 minutes and can be completed in person, over the phone, or through
 messaging.
- Recovery Planning Sessions: used to record individual coaching services where coaches work with the
 participant to maintain and progress on their recovery plan and help with barrier reduction and systems
 navigation.
- **Group Sessions:** used to record a recovery coaching or recovery planning session where 2-12 participants are engaged and participate in group discussion facilitated by 1-2 recovery coaches.

Project History

Harbor Care (formerly Harbor Homes) was contracted in July 2016 to serve as the Facilitating Organization (FO) for the State of New Hampshire's effort to support the sustainable and integrated development of Recovery Community Organizations (RCO) and their delivery of Peer Recovery Support Services (PRSS). RCOs and Recovery Community Centers (RCCs) were known elsewhere in the country to fill gaps in addiction treatment and recovery infrastructures and to grow numbers of people accessing vital supports to achieve and sustain long-term recovery. New Hampshire's innovation of funding a Facilitating Organization to aggressively grow a collaborative workforce of community based PRSS providers has contributed to an improved system of care for people affected by addiction.

The PRSS field, though new relative to clinical disciplines and unorganized peer support fellowships, has demonstrated measurably improved outcomes for program participants before, during, after, and in lieu of traditional addiction treatment services. Dramatic outcomes are demonstrated in New Hampshire by way of personal accounts and measurable outcome data through the use of a peer friendly electronic health record, RecoveryLinkTM.

In summer 2016, the FO completed an environmental scan to identify grassroots organizations' preparation for accreditation by the Council on Accreditation of Peer Recovery Support Services (CAPRSS). Those organizations deemed "most ready" for CAPRSS accreditation were subcontracted under the FO. In September 2016, the FO subcontracted with three organizations in three different Public Health Regions, providing those organizations with technical and operational support, start-up funding, and monthly reimbursement-based funding after the first two months. Two additional organizations were subcontracted in December 2016; two between January and May 2017, two were subcontracted in July 2018, one in March 2020, and two additional centers in March 2021 to position FO-supported RCOs in twelve of the state's thirteen Public Health Regions. The FO continues to identify and work with multiple organizations and grassroots efforts to expand quality peer recovery support services in underserved areas of the state.

The FO is starting to explore opportunities to share subject matter expertise beyond the state of NH as of 2023. These opportunities include being a subject matter expert on the Peer Recovery Innovation Network external advisory board as they look for opportunities to advance recovery support services through innovation and research. The Assistant Project Direct and Project are also approved subject matter experts for the National Peer Center for Excellence allowing them to provide technical assistance to Recovery Community Organizations across the country. Harbor Care is also a registered stakeholder for the National Peer Center for Excellence.

FY23 Project Summary

Harbor Care, Inc. was contracted to provide facilitating organization (FO) services for the 12 Recovery Community Organizations (RCOs) in NH that provide Peer Recovery Support Services (PRSS) to individuals with Substance Use Disorder (SUD) and their families. FO services include but are not limited to:

- Provide funding and assistance for operational and programmatic support to each RCO.
- Support the provision of quality PRSS within each recovery center.
- Monitor each subcontractor's compliance through regularly occurring meetings.
- Subcontract with 12 RCOs totaling 19 open RCCs providing PRSS.
- Ensure each subcontracted RCO provide a minimum of one recovery center, recovery coaching, telephone
 recovery support, a venue for mutual aid meetings, additional support as determined by the local
 community, engage with local and regional partners, and comply with all applicable state and federal laws,
 rules, and regulations.
- Work to maintain existing recovery centers and establish new centers in underserved geographic regions.
- Work with each subcontractor within each centers' administrative capacity and readiness to reach the
 following goals; meet the NH RCO Standards of Excellence (NHRCOSOE), Medicaid enrollment and
 billing, capacity building, sustainability, and service development.
- Assist subcontractors with ongoing back-office functions as needed included but not limited to HR, IT,
 P&P development, grant writing, compliance monitoring, quality improvement, billing, and data collection and management.
- Ensure training and TA is available to recovery center staff including but not limited to recovery coaching, TRS, co-occurring disorders, family dynamics of addiction, ethical standards, information security, and HIPAA.
- Facilitate a Community of Practice (CoP) that allows administrators and leaders to establish and strengthen cooperation, collaboration, and informal mentoring.
- Ensure RCOs are providing CRSWs with supervision in compliance with the NH Licensing Board.
- Implement data collections and organization process using RecoveryLink.
- Collaborate with the Department to evaluate service performance and participant level outcomes and enhance contract management.
- Actively promote the availability, purpose, and value of PRSS across NH.
- Facilitate monthly RCO leadership meetings.

Funding Breakdown

The FO currently manages a single contract with multiple funding streams including; SORII, Governor's Commission on Alcohol and Other Drugs, General Funds and Block Grant dollars. The PRSS FO contract is

overseen by the NH Department of Health and Human Service (DHHS), Bureau of Drug and Alcohol Services (BDAS) and currently provides funding to nineteen RCCs. On average, PRSS FO funding supplements 67% of subcontracted RCO's annual operating budgets. RCOs also have independent grants and funding revenues not managed by Harbor Care that help support their day-to-day operations and programming.

FY 2023 Highlights

- Harbor Care regularly attends the LADC Board, Governor's Commission on Alcohol and Other Drugs, and Opioid Abatement Committee meetings.
- Project Director is a member of the Governor's Commission on Alcohol and Other Drugs' Budget Taskforce.
- Assistant Project Director is a member of the Governor's Commission on Alcohol and Other Drugs' Data Taskforce.
- Harbor Care continues to provide updated procedures, training, and TA for data input into RecoveryLink.
- Harbor Care continues to facilitate shared learning and open communication forums for RCO's through the RCO Association:
 - Harbor Care facilitates a bimonthly Data Quality Forum which allows RCOs to learn and ask questions about data monitoring and quality assurance procedures.
 - Harbor Care facilitates a biweekly meeting for all RCO Directors to discuss program and contract updates.
 - O Harbor Care facilitates a monthly parenting education meeting that allows trained parenting facilitators to discuss ongoing curriculum implementation.
 - O Harbor Care facilitates an ethics committee that allows directors to seek feedback and work through ethical dilemmas with other RCOs as problems arise.
 - Harbor Care continues to provide Community of Practice trainings quarterly with Technical Assistance being provided by Growth Partners.
- FO staff are active members of Harbor Care's Quality Assurance and Improvement, Workplace Violence Prevention, Emergency Preparedness, and Justice, Equity, Diversity, and Inclusion work groups.
- Harbor Care continues to manage RCO's use of MedTrainer's Learning Management System to ensure all RCO staff receive regular privacy and cybersecurity training.
- Assistant Project Director & Project Director are approved technical assistance providers for the National Peer Center for Excellence.
- Project Director presented at the NH Opioid Abatement Trust Fund & Advisory Commission meeting about RCO service models and the FO's technical assistance.
- Harbor Care meets regularly with NH DHHS, BDAS, and Arkansas Foundation for Medical Care (AFMC) to develop and formal evaluation plan to evaluate NH PRSS and associated outcomes.
- Harbor Care, NH DHHS, BDAS, and AFMC finalized a <u>public facing dashboard</u> displaying aggregate RCO service numbers and demographics.
- Harbor Care, NH DHHS, BDAS, and AFMC finalized a <u>comprehensive evaluation</u> of FY21 RCO services and outcomes.
- Harbor Care, BDAS, and Growth Partner's finalized a procedure for the NH RCO Standards of Excellence
 to ensure RCOs are providing quality services in alignment with national standards. Two RCOs went
 through this process this year and were both deemed to meet standards.
- Project Director participates as a subject matter expert on the Peer Recovery Innovation Network external advisory board.
- Harbor Care provided back-office services and technical assistance to all RCOs.
- Harbor Care provided oversight of subcontracted RCO rollover onto new version of RecoveryLink.
- Harbor Care continues to support RCO's in Medicaid applications and MCO applications.
- FO has hired a part time administrator and recently onboarded a part time project management intern from Southern NH University.

- Harbor Care has funded ongoing Impact Leadership Training for RCOs and FO staff through the Communities Project.
- Harbor Care provided scholarships for RCO staff/volunteers to attend RICH Conference.
- Harbor Care continues to engage the public via NH Recovery Hub Facebook page.
- In process of developing new Recovery Hub website to launch in FY24.

Training

Subcontracted RCOs have participated in diverse and practical trainings aimed at broadening the scope of PRSS and improving PRSS delivery, organizational capacity, and sustainability. Standards of Excellence

To date, eight of the subcontracted RCOs have been accredited through the Council on Accreditation of Peer Recovery Support Services (CAPRSS), a program of Faces & Voices of Recovery. SOS Recovery Community Organization, which had been assessed as 'most ready' for accreditation during our initial RCO scan in 2016, received an Exemplary five-year accreditation status in June 2018. Navigating Recovery of the Lakes Region and Safe Harbor received Standard three-year accreditation status in early 2019. Archways, Keene Serenity Center, and White Horse Recovery all received CAPRSS accreditation during fiscal year 2020. Hope for NH Recovery, who was previously accredited by CAPRSS in 2016 for a five-year accreditation, joined the Facilitating Organization as a subcontractor during the second half of fiscal year 2020. Revive Recovery Center received their 3-year accreditation in January 2021.

CAPRSS's measures include four core areas of standards (Principles, People, Practices, Performance) and thirty domains that are assessed by the RCOs themselves and through a peer review process. The four core areas of standards in the CAPRSS accreditation process – Principles, People, Practices, and Performance – refer to the mission, vision, and code of ethics that a center follows; the participants served by the center and the community the center is in; the way that the centers go about helping their participants and benefit the overall community; and the data showing that the centers are performing at the highest level – both through fiscal responsibility and overall outcomes for participants.

Together with Growth Partners, a third-party organization that provides technical assistance to non-profits, and BDAS, the FO developed a process to ensure NH RCOs meet CAPRSS standards without requiring the organizations to go through the formal and expensive accreditation process. The NH Recovery Community Organization Standards of Excellence is a five-step process which includes organizational development, a desk review, site visit, findings report, and reassessment. During organizational development, RCOs will attend regular one-on-one meetings with FO staff to assist with preparing for the review. The center staff will be given opportunities to ask questions and have FO staff review documents informally prior to the desk review. After the center has indicated that they are ready for the desk review, BDAS will review all relevant and required documentation from the centers to ensure that the centers' policies, procedures, and financials meet standards. Using information collected in the desk review, BDAS will then develop a site visit agenda that is tailored to each center based upon the findings in previous steps. During the site visit, the center staff, board members, volunteers, and some participants will be interviewed about organizational policies and procedures.

Based upon the findings of the desk review and site visit, BDAS will score the organization, which will determine whether they meet or exceed the defined standards of excellence. BDAS will provide a report to the RCO and to the FO with a summary of findings and recommendations. If a center is found to not meet standards, they are provided with recommendations and a period of six months to address necessary changes before a new desk review and site visit are performed. The review findings are also used to: identify RCO strengths, lessons learned, and unique and notable practices that can be shared with other RCOs, identify challenges that can be addressed through FO technical assistance or other resources and lastly, monitor and document RCO development over time through subsequent reviews.

There are twenty-eight NH RCO Standards of Excellence which are organized into six domains, they include:

I. Structure and Staffing

- a. The RCO structure supports its ability to achieve its vision and carry out its mission and core responsibilities.
- b. The RCO staffing supports its ability to achieve its vision and carry out its mission and core responsibilities.
- c. The RCO has developed sustainable partnerships with other organizations in its service area that enhance its ability to advance its vision, mission, and core values.

d. The RCO uses effective processes to market peer recovery support services and encourage community members to support and participate in RCO programs.

II. Board of Directors

- a. BOD membership is representative of, and responsive to, local communities of recovery.
- b. The BOD has a defined structure and roles and responsibilities for members.
- c. BOD organizational policies and procedures are consistent with the principles of good governance.
- d. The BOD uses participatory processes with diverse recovery and other community members to solicit their input, engage them in strategic planning, and ensure cultural competency.

III. Assessment and Planning

- a. The RCO collects, analyzes, and uses valid and objective data to identify recovery support needs.
- b. The RCO collects, analyzes, and uses valid and objective data to plan improvements to service delivery and access.
- c. The RCO uses participatory processes to engage partners and stakeholders—including those who are in, or seeking, recovery—in planning efforts.

IV. RCO Workforce

- a. The RCO provides policies and procedures to all staff and volunteers that outline requirements for the positions, rules of the center, and local and federal regulations.
- b. The RCO has a defined process for determining the number of staff and volunteers needed to provide effective programming.
- c. The RCO has defined roles and responsibilities for all staff and volunteers.
- d. The RCO has efficient and effective processes to recruit quality staff and volunteers.
- e. The RCO has efficient and effective processes to retain quality staff and volunteers.
- f. The RCO has a process for regularly providing reviews, feedback, and disciplinary measures to staff and volunteers.
- g. The RCO provides training opportunities for staff and volunteers that are relevant to their roles in the organization.

V. Operations

- a. The RCO has established defined operational policies and procedures for the staff and volunteers at the center
- b. RCO operational policies and procedures are easily accessible to staff and volunteers.
- c. RCO operational policies and procedures are regularly reviewed and updated as needed.
- d. The RCO has the financial resources in place to provide necessary recovery supports and programming.
- e. RCO services are responsive to the demographics and needs of those who are in, or seeking, recovery in the service area.

VI. Monitoring and Evaluation

- a. The RCO has internal financial controls and systems to follow accepted accounting principles and accurately track the time of staff and volunteers.
- b. RCO staff have effective processes for monitoring the quality with which recovery support service and programs are implemented.
- c. RCO staff have effective processes for analyzing and using monitoring and evaluation data to improve the quality with which recovery support service and programs are implemented.
- d. RCO staff accurately collect and report program data in accordance with all requirements.
- e. The RCO has procedures in place to analyze and use program data to evaluate the impact and effectiveness of recovery supports and services and plan to improve outcomes.

Each RCO is engaged in the review process at an appropriate stage relative to its organizational capacity and maturity in developing, delivering, and documenting PRSS. The FO provides regular meetings with recovery centers to provide support and technical assistance as they prepare their organization for their assessment of SOE standards.

Medicaid Reimbursement

In FY21 the FO attended multiple webinars and Q&A sessions with NH Department of Health and Human Services and Program Integrity regarding policies and procedures for RCOs to bill Medicaid for reimbursement. An RCO Billing Manual was developed and approved by DHHS that summarizes the relative He-W 513 SUD provider rules for subcontracted RCOs to reference as they each work towards eligibility for Medicaid reimbursement. Subcontracted RCOs continue to get support from Harbor Care throughout this entire process including applying for Medicaid IDs, contracting with individual Managed Care Organizations (MCOs), and providing monthly billing templates for claims submissions for each eligible RCO. There are currently seven RCOs actively billing Medicaid. Of the five RCOs that use a third-party biller contracted through Harbor Care, a total of \$564,692 was received in reimbursement from NH MCOs in FY23.

Sustainability

Each RCO has been successful in leveraging FO funds for service contracts and grants which expand their scope of work. A majority of subcontracted RCO's receive additional funding for a variety of programs including but not limited to recovery coaching in the emergency department, probation and parole relationships, Recovery Friendly Workplace initiatives, homeless outreach, etc. All RCO's are in close working relationships with their regional Doorways. However, most RCOs still face capacity issues related to their expanded roles in their communities.

Sustainability needs will become clear once regular and consistent service reimbursements are received from Medicaid MCOs. The FO will work individually with all RCOs to establish and maintain their unique sustainability plans with their individual revenue streams and programming. A majority of RCOs are just starting the detailed process of sustainability planning for their programs. Harbor Care predicts that sustainability planning will be a primary focus of TA and training needs in the upcoming fiscal years.

Data Collection

Data collected and summarized below comes from two sources; organizational data from RCOs and service/participant level data collected in RecoveryLinkTM.

RecoveryLinkTM is a modern company with a mission to provide a suite of accessible and impactful recovery support tool designed to elevate collective impact. The platform "offers recovery community organizations, peer recovery support providers, and enterprise health systems a suite of digital tools platform designed to improve outcomes through systems transformation." (RecoveryLink, 2021). The cloud-based program offers a secure platform for recovery providers to record recovery data and outcomes.

On June 16, 2023 RecoveryLink migrated all RCOs on to a new platform. <u>Data summarized below reflects the time</u> period of July 1, 2022- June 16, 2023, data for the complete fiscal year including demographics and service <u>numbers will be made available on NH's Health and Human Services Data Portal-Recovery Services as soon as available.</u>

Participant Demographics

Participant demographics include age, gender, race, ethnicity, sexual orientation, and veteran status. The below data tables represent total demographic information for participants that received at least one peer recovery support service in fiscal year 2023. Of the 3,017 unique individuals served throughout the fiscal year, the primary demographic is 25-44-year-old, heterosexual, white, non-Hispanic, men who are not veterans.

Participant Services

PRSS as they are defined for purposes of potential Medicaid billing are exclusive to individual or group Recovery Coaching and continuous recovery monitoring (or telephone recovery support). However, PRSS as delivered by NH RCOs include a broad array of services, including police-assisted recovery response programs; housing and other basic needs assistance; treatment/health systems navigation; inter/intraorganizational group facilitation; homeless outreach; hospital and emergency department response; transportation; services delivered to family members; community outreach and education, adventure outings, naloxone training and distribution, syringe service programs, fentanyl test strip distribution, etc. RCOs utilize the various engagement types in RecoveryLink to record these different services including recovery planning sessions, brief check ins, care coordination, referrals, contact logs, and activity logs. *In FY23 FO funded RCOs provided 33,207 individual services and 26,822 activities with 143,784 people in attendance and 311,626 items distributed.* The following tables offer fiscal year totals for services provided by subcontracted RCOs including intakes, recovery planning sessions, referrals, brief check ins, group sessions, and activity logs.

Participant Outcomes

The primary method outcome data collection is the Brief Assessment of Recovery Capital (BARC-10). The BARC-10 is an assessment of recovery capital measured on a scale from 10-60. Recovery capital is the measure of internal and external assets that can be utilized by recoverees to initiate and sustain recovery (Cloud & Grandfield, 2008). The initial Assessment of Recovery Capital (ARC) identified 10 primary domains (substance use and sobriety, global psychological health, global physical health, citizenship and community involvement, social support,

meaningful activities, housing and safety, risk-taking, coping and life functioning, and recovery experience) across 50 questions (Groshkova, Best & White, 2013). The BARC-10 was derived from the initial ARC tool to assess each domain for a total of 10 questions. This brief assessment tool is used to evaluate recovery support services and their effectiveness on recovery related outcomes, inform recovery support providers' service delivery, and provide a strength-based measurement of progress for the recoveree. It is recommended that this assessment be used at intake and a minimum of one month during ongoing service engagement.

All subcontracted RCOs consistently demonstrate increases in the recovery capital of their participants when comparing baseline BARC-10 scores to their most recent BARC-10 scores. RCO's have a standard goal of completing a BARC-10 at least 30% of the time during ongoing engagements with participants. This benchmark completion rate goal was originally set to help increase the sample size (number of participants with 2+ BARC-10s completed) to determine statistical significance. In support of these goals, the FO provides ongoing technical assistance to the RCOs to help improve data monitoring and quality improvement efforts and also facilitates a forum for the RCOs to share what strategies have been successful or unsuccessful in this area.

- We have partnered with the Teatotaller Café in Concord as well as the Homestead Men's recovery home to offer consistent in person recovering together cafes, and we are still currently offering remote parent cafes.
- Our family support program is offering Positive Solutions for Families as well as Families in Recovery. Parenting the Second Time Around (PASTA) was facilitated this quarter, with a total of 4 participants.
- We were able to provide transportation to 43 participants throughout the quarter, assisting in overcoming location and transportation barriers to legal obligations, medical appointments, retail locations, DMV, and other obligations to assist in building recovery capital.
- We continue to partner with Healthfirst, a Federally Qualified Healthcare Clinic, in providing wraparound services, and every Friday Healthfirst facilitates a medically assisted treatment program out of our Franklin location.
- With the recent launch of our youth programming, we have held 9 alternative peer groups in the Franklin High School and over the course of the quarter, we have supported a total of 18 youth in alternative peer groups. We are continuing our work with UNH Institute on Disability (UNHID) for quality assurance in this program. We recently held our first review with UNHID and it has been determined that we are providing this support program to fidelity.
- Individual delivery of the 7 Challenges program was underway this quarter, one individual attended 7 sessions.
- 27 units of Narcan were distributed this quarter.
- 15 distribution activities were recorded this quarter, items distributed include personal hygiene kits, tents, and gas cards.

Quarter Highlights

- Multiple staff have successfully completed the Building Futures Together Program through the UNH Institute on Disability, positioning Archways as a center with the ability to assist youth with a history or family history of substance use concerns.
- Archways partnered with Healthfirst, Navigating Recovery, Laconia PD, and the
 Doorway to create a peer recovery response team (PRRT) program modeled
 loosely on our existing ACERT program in an effort to better assist individuals who
 experience contact with law enforcement discover recovery options available to
 them. This quarter Archways was able to hire a new staff member to fill this
 position. Our PRRT program is expected to pilot in Laconia as well as Tilton in
 partnership with each town's police departments.
- Recovery Exercise Program for long term Success (REPS) program has continued.
 This quarter Archways is offering it's second cohort of REPS programming. Our
 wellness center has been equipped with the help of financial assistance from
 Franklin Savings Bank and NH Charitable Foundation.
- In addition to the REPS program, Archways also began offering a Yoga program to interested participants this quarter.
- This quarter Archways staff supported a participant, who had been experiencing homelessness for almost a decade, successfully engage in a housing program, where she now has access to long term housing.
- Another participant was also supported through center resources and supports in gaining access to her own apartment, allowing her to live with her daughter and work towards regaining custody of her other children.
- Archways designated Family Threads program has gained momentum this quarter and is now serving 6 families. One of the family threads families who staff have been supporting for over a year, has maintained his recovery journey, established a stable living environment, and was most recently granted full custody of his child.
- Tilton Northfield Old Home day was well attended, in spite of the weather. We were able to give out several Narcan Kits and Deterra bags as well as talk to several people about programming. It is estimated that 200 people attended this event.
- Archways participated in Franklin's Community Day event this quarter and outreached to an estimated 122 people.

	 Archways staff presented recovery program and prevention information to youth at both the Franklin High School New Student Orientation event, as well as the 'No Safe Experience' Event. An average of 40 students were present at each event. This quarter recovery coaches were successful in supporting multiple participants in accessing and engaging in treatment to address their substance/alcohol use disorders. Substantial funding was granted this quarter that will support the sustainability of Archways newly implemented Youth Programming, as well as the continued development and implementation of the Community Corrections program.
Challenges	 Housing availability and affordability continues to present challenges to our participants. The lack of low to moderate income apartments especially presents tremendous hurdles for participants who have felony criminal backgrounds or previous evictions on their records. Increased need for data for multiple grants has placed difficulty on staff members. Data gathering and preparation is not a job function accounted for by grants, leaving this task to employees who must take time from their primary roles. Currently our financial support role is contracted out. We are finding that having this arrangement is causing difficulty and delay in completion of tasks, as we are certainly not the contractor's only account. Archways began interviewing other financial firms and came to a decision on contracting with a larger national financial firm that deals primarily with non-profits. Over the past year wages in our general area for entry level positions have increased dramatically, making it difficult to remain competitive and hire new staff. For example, McDonalds is hiring new staff at approximately \$17.00/hr in our area. Archways currently pays new recovery support staff at \$15.00/hr, which bumps to \$20.00/hr upon obtaining a CRSW credential. With so many employers hiring at wages more than what we are able to offer, hiring has continued to suffer. Across multiple grants we remained level funded compared to last year, even as operational expenses have increased rapidly. With utilities and regular bills such as heat, electricity, phones, etc. increasing rapidly, we have been unable to offer regular raises to staff across the agency. Staffing coverage at the Concord location has been challenging over the last quarter, with staff working on programs outside of the center or participants needing to meet in the community – leaving the center with needed coverage. Management continues to meet to discuss staffing patterns at this location to develop a reasonable solution, a

Hope's 8th Annual Recovery Festival drew more sponsors and more attendees than ever before, maintaining its status as the largest recovery celebration in the state. For three hours, Veterans Park in Manchester was filled with people celebrating their recovery, sharing their stories, demonstrating their musical talents and, in general, demonstrating that recovery is possible for anyone. We become so attached to positive outcomes for our members that we blame ourselves when success doesn't come right away. The constant battle finding and maintaining balance while still trying to help others walks a fine line. Often at Hope our staff members and leadership team can be heard saying, "I'll do whatever it takes for Hope and our members"; unfortunately, whatever it takes can often lead to staff rearranging priorities. While we each encourage others to take time for themselves, to leave work behind and to maintain our own recovery, too often we don't take our own A constant struggle is finding and retaining peer support workers. PROGRAM UPDATES

Our center hosts mutual aid meetings such as AA, All Recovery, Mental Health and Wellness in Recovery and the areas only HA Group. We offer a transportation program for people in recovery called "Road to Recovery" and it is currently at full capacity offering 80 rides per week. We offer local MAT rides 6 days a week. We partner with DOC to offer rides to inmates who are leaving for treatment. We also support individuals in long term recovery with specific health appointments. We support volunteerism and are super thankful and grateful to those that support our mission. Our volunteers help make peer driven transport possible,

	 support our groups, keep the facility clean and safe, build harm reduction and wound care kits and fill roles on our board of directors. We offer Harm Reduction services, including a syringe services program called GROW SSP. We receive support and funding from NH Harm Reduction Coalition. Homeless outreach. All our staff engage directly with a multitude of individuals and organizations to help gain some form of housing security for individuals. We offer our group CRSW supervision for the community along with our staff and volunteers.
Quarter Highlights	 Our new space is working out well. The lack of parking is the only real drawback, and the reality is that most of our demographics do not drive. The neighborhood relations have improved greatly. We act as a team and share resources, staff and programs. Our landlord is the local mental health peer support agency, MPS-Monadnock Peer Support. One of our volunteers was able to complete all requirements to submit and receive their CRSW. She has since taken a full-time leadership role at another RCO. In July, we will be celebrating 10 years as an organization and will be holding a celebration on July 15th. Our founder, Gary C., celebrated 40 years of continuous recovery on June 29. We do recover- together. We continue using social media to engage the public. Social media platforms work well with individuals that have no cell service but have wifi access. We had a visit from Congresswoman Ann Kuster that was fantastic. She interacted with every participant and staff member and is supportive of the work we all do and its importance.
Challenges	 Finding housing is getting harder for participants. The prices of rentals are still rising, and availability is slim. On the same subject, one of the local men's sober living facilities shifted away from housing to detox only. This lost us housing for 26 that covered 90 days sober living. We are putting all the energy into harm reduction and recovery supports-offering more and it seems like overdoses are increasing. It is sad and tiring. We will keep on trying and do recognize that we see success also.

Service Delivery	 PRSS & TRS: The primary service we offer to participants is one-on-one peer supports, either in person, over the phone, or via Zoom. PRSS & TRS includes brief check-ins, follow-up engagements, helping participants achieve goals set in their recovery wellness plans, and providing case management / system navigation. Street Outreach: Three days a week the coaches go out in pairs to provide street reach to people experiencing housing insecurity and homelessness. Coaches offer treatment and recovery resources, hand out tents, blankets, socks, naloxone, personal hygiene products, etc., and provide PPE, rapid COVID tests, and vaccine information. Compass House: We continue to provide weekly house meetings and one-on-one coaching to the 8 women at Compass House. CORE Groups: Weekly group meetings are held at Belknap County Corrections for the residents in the Correctional Opportunity for Recovery and Education Program. 24/7 Hospital Support: This quarter we saw 67 patients in the hospital and referred patients to withdrawal management, treatment (all levels of care), sober living, group meetings, The Doorway, and peer support services. Parenting Journey II and Families in Recovery: Weeks 5-12 & 5-17 were held this quarter. Pro-social activities: This quarter we continued the free bagged lunch program on Saturdays from 12-1 pm, free BBQs the first Saturday of the month, and hiking group the 1st and 3rd Saturdays of the month. LEX (Laconia Exchange): This quarter we started a SSP. Since April we have collected over 2,200 syringes and distributed over 2,500 (88% return rate). In addition to the safe use kits, we also distribute wound care kits, condoms, HIV athome test kits, and other essential items.

PROGRAM UPDATES

Service Delivery

- SOS is providing 1:1 comprehensive supports and brief check ins. We also provide Nurturing Parenting/Families in Recovery. We have multiple digital meetings being held 7 days a week.
- We offer onsite in person meetings and support services at all centers.
- SOS extended work we did with our previous subcontract through DOJ and received funding for our Peer-Strength Program from NH Opioid Abatement Commission. We are now working in multiple counties. Added Rockingham County Treatment Court this quarter to Coos, Carroll, Cheshire, Strafford County and Federal LASER program in Concord.
- SOS had a successful Recovery, Inclusion, Community & Harm Reduction Conference (RICH) conference. Over 250 attended and is the largest peer-recovery and harm reduction conference in New England. We are now planning the 2024 conference for April 2024.
- Engagement with our fee-for-service recovery coaching contract w/Exeter
 Hospital has been increasing. We are exploring a project with CORE Physicians to
 provide support to primary care providers.
- Our new training initiative has launched and as a result we are providing a number of trainings around Recovery Support Services, Harm Reduction and Motivational Interviewing.

Quarter Highlights	 RICH Conference with over 250 attendees, 35 exhibitors with 12 breakouts and 5 keynote speakers for 2 days in April 2023. SOS continued collaboration with NHHRC on harm reduction supports and services and is subcontracting a care coordination contract. SOS has been continuing engagement with the New England Regional Justice Opioid Initiative (NERJOI) and serving on their emerging issues taskforce. SOS presented to the annual justice meeting with treatment court judges and treatment teams in Concord in June on Drug Trends in NH. SOS completed offering training to approximately 40 as a subject matter expert in the UNH Citizens Initiative substance use disorder ECHO training. 2 more staff were trained in the Invitation to Change, Level 1 for family supports. Transition of SOS as a program of Greater Seacoast Community Health to a separate entity was completed on June 30. Finalizing the work at our new social enterprise project in Somersworth, NH which will be a workforce development effort. The restaurant, Fold'd should be ready to open this summer. Trained 26 police, first responders and community mental health workers in Vermont on Motivational Interviewing which helps build revenue and sustainability for expansion of training offerings.
Challenges	 Funding continues to be a challenge with the FO contract being a 2% decrease through June and a 4% increase from July-Sept. Workforce availability is also challenging and we continue training in workforce development. State support with funding for us to improve workforce would be welcome. Finding funds for syringe service programs within recovery is a major barrier in NH to helping people find recovery. Evidence based data on providing harm reduction supports in our RCO is not counted except to gather supply distribution. No valid way to capture engagements towards funding models and deliverables that are critically important, evidence based, and impactful despite the evidence it increases access to recovery.
