Definitions

- **Digital Recovery Support Services (DRSS):** PRSS services that are provided through online or telephonic platforms in lieu of face to face contact.
- Peer Recovery Support Services (PRSS): Social support designed and delivered by people who have experienced Substance Used Disorder and recovery. This peer-based model helps individuals engage in the recovery process and embodies a message of hope for the recovering community (SAMHSA, 2009).
- **Recovery:** a process of change through which people improve their health and wellness, live self-directed lives, and strive to reach their full potential (SAMHSA, 2020). There are four major dimensions that support recovery:
 - Health—overcoming or managing one's disease(s) or symptoms and making informed, healthy
 choices that support physical and emotional well-being.
 - o **Home**—having a stable and safe place to live.
 - Purpose—conducting meaningful daily activities and having the independence, income, and resources to participate in society.
 - Community—having relationships and social networks that provide support, friendship, love, and hope.
- Recovery Capital: Conceptually linked to protective factors and wellness, Recovery Capital can be divided into three categories; personal, family or social and community. These categories encompass factors such as physical health, basic needs, social relationships, attitudes, policies, and other resources (W. White, W. Cloud, 2008). Recovery Capital is measured through the Brief Assessment in Recovery Capital (BARC-10) assessment tool on a scale of 10-60.
- Recovery Coaching (RC): One-to-one mentoring wherein focus is to work with the service recipient in development and accountability with a personal Recovery Wellness Plan. Help with barrier reduction and systems navigation is also expected. Relationship is ongoing until terminated by either party.
- Recovery Community Center (RCC): Peer operated centers that serve as local resources of community-based recovery support and help build recovery capital among individuals and the community (Recovery Research Institute). A single Recovery Community Organization can have multiple centers.
- Recovery Community Organization (RCO): "An independent, non-profit organization led and governed by representatives of local communities of recovery. These organizations organize recovery-focused policy advocacy activities, carry out recovery-focused community education and outreach programs, and/or provide peer-based recovery support services" (P. Valentine, W. White, P. Taylor, 2007).
- Telephone Recovery Support (TRS): Weekly outgoing calls to individuals for brief check-ins on his/her/their status and progress in recovery. Referral to other resources is expected. Relationship usually lasts the length of each call, with multiple RCO representatives calling daily lists of program participants.
- Activities/Activity Logs: Group services that can cover a variety of topics. Some common group activities that
 RCOs host are anonymous step groups, family support groups, art, music, and writing groups, yoga, and mutual
 aid meetings. RCOs are also able to track any trainings or outreach they offer to the public or their local
 communities.
- Brief check ins: are used to record Telephone Recovery Support service engagements in RecoveryLink. These
 engagements typically last less than 15 minutes and can be completed in person, over the phone, or through
 messaging.
- Recovery Planning Sessions: used to record individual coaching services where coaches work with the
 participant to maintain and progress on their recovery plan and help with barrier reduction and systems
 navigation.
- **Group Sessions:** used to record a recovery coaching or recovery planning session where 2-12 participants are engaged and participate in group discussion facilitated by 1-2 recovery coaches.

Project History

Harbor Care's (formerly Harbor Homes) mission is to provide essential services, including housing and healthcare, to those in need within the community. Their vision is a world where everyone lives safe, stable, and healthy lives filled with purpose, dignity, and respect. Guided by a philosophy of care rooted in compassion and respect, Harbor Care believes everyone deserves dignity, stability, and opportunity. Through housing, healthcare, and supportive services, they empower individuals and families to overcome challenges and achieve lasting well-being, fostering hope and stronger, more resilient communities. Their core values—compassion, respect, collaboration, and transparency—guide their actions and interactions, ensuring a positive impact, inclusive environment, empowered voices, and trust through clear communication. Harbor Care was contracted in July 2016 to serve as the Facilitating Organization (FO) for the State of New Hampshire's effort to support the sustainable and integrated development of Recovery Community Organizations (RCO) and their delivery of Peer Recovery Support Services (PRSS). RCOs and Recovery Community Centers (RCCs) were known elsewhere in the country to fill gaps in addiction treatment and recovery infrastructures and to increase the number of people accessing vital supports to achieve and sustain long-term recovery. New Hampshire's innovation of funding a Facilitating Organization to aggressively grow a collaborative workforce of community based PRSS providers has contributed to an improved system of care for people affected by substance use.

The PRSS field, though new relative to clinical disciplines and unorganized peer support fellowships, has demonstrated measurably improved outcomes for program participants before, during, after, and in lieu of traditional addiction treatment services. Dramatic outcomes are demonstrated in New Hampshire by way of personal accounts and measurable outcome data through the use of a peer friendly electronic health record, RecoveryLinkTM.

In summer 2016, Harbor Care completed an environmental scan to identify grassroots organizations dedicated to providing peer support within the state of NH. Those organizations deemed "most ready" to meet standards set by the Council on Accreditation of Peer Recovery Support Services (CAPRSS) were offered subcontracts with Harbor Care under the FO. In September 2016, Harbor Care currently subcontracts with 10 RCOs servicing 21 different locations across all 13 of NH's Public Health Regions. Harbor Care continues to identify and work with multiple organizations and grassroots efforts to expand quality peer recovery support services in underserved areas of the state.

Great efforts have been made to share subject matter expertise in Recovery Community Organizations and PRSS on a more national level. These efforts include;

- Broadly sharing statewide PRSS evaluation data to national partners including submitting abstracts for multiple conferences and providing didactics and case studies for the Peer Recovery Innovations Network's Recovery Science Echo.
- Registered stakeholders with the National Peer Center for Excellence.
- Member of the Peer Recovery Innovation Network external advisory board as they look for opportunities to advance recovery support services through innovation and research.
- Providing technical assistance and consulting work with multiple RCOs in the Greater Boston area.
- Provided technical assistance to the University of New Hampshire for Alternative Peer Groups.
- Participating in Center for Addiction Recovery Support (CARS) Program Evaluation Learning Community.
- Working collaboratively with Third Horizons Strategies developing and implementing alternative payment model.
- AFMC findings on the effectiveness of the Facilitating Organization (FO) model highlight Harbor Care's pivotal role in driving the success of New Hampshire's Peer Recovery Support Services (PRSS) network.

Over the past eight years, the FO model has proven effective in expanding access, improving service quality, and enhancing sustainability across the state. Harbor Care's coordination efforts have enabled Recovery Community Organizations (RCOs) to operate efficiently, align with state priorities, and maintain high standards of care. Key outcomes include the development of a collaborative statewide network, increased capacity in rural and underserved areas, standardized data collection through RecoveryLink, and measurable improvements in participant outcomes. Additionally, the FO has supported financial sustainability through Medicaid billing and equitable funding allocation, while also advancing advocacy efforts and reducing stigma. Despite these achievements, AFMC identified ongoing challenges, such as funding instability, the evolving scope of FO responsibilities, and the need to balance standardization with local flexibility. Addressing these challenges through stable, multi-year funding, streamlined financial models, and adaptable frameworks will be essential to preserving and building upon the PRSS network's success.

FY25 Project Summary

Harbor Care was contracted to provide facilitating organization (FO) services for Recovery Community Organizations (RCOs) in NH that provide Peer Recovery Support Services (PRSS) to individuals with Substance Use Disorder (SUD) and their families. FO services include but are not limited to:

- Provide funding and technical assistance for operational and programmatic support to each RCO.
- Support the provision of quality PRSS within each recovery center.
- Monitor each subcontractor's compliance through regularly occurring meetings.
- Subcontract with 10 RCOs totaling 21 open RCCs providing PRSS.
- Ensure each subcontracted RCO provide a minimum of one recovery center, recovery coaching, telephone recovery support, a venue for mutual aid meetings, additional support as determined by the local community, engage with local and regional partners, and comply with all applicable state and federal laws, rules, and regulations.
- Work to maintain existing recovery centers and establish new centers in underserved geographic regions.
- Work with each subcontractor within each centers' administrative capacity and readiness to reach the
 following goals; meet the NH RCO Standards of Excellence (NHRCOSOE), Medicaid enrollment and
 billing, capacity building, sustainability, and service development.
- Assist subcontractors with ongoing back-office functions as needed included but not limited to HR, IT, policy and procedure development, grant writing, compliance monitoring, quality improvement, billing, and data collection and management.
- Ensure training is available to recovery center staff including but not limited to recovery coaching, TRS, co-occurring disorders, family dynamics of addiction, ethical standards, information security, and HIPAA.
- Facilitate a Community of Practice (CoP) that allows administrators and leaders to establish and strengthen cooperation, collaboration, and informal mentoring.
- Ensure RCOs are providing CRSWs with supervision in compliance with the NH Licensing Board.
- Implement data collections and organization processes using RecoveryLink.
- Collaborate with the Department to evaluate service performance and participant level outcomes and enhance contract management.
- Actively promote the availability, purpose, and value of PRSS across NH.
- Facilitate monthly RCO leadership meetings.
- Provide oversight to 3 Opioid Abatement funded programs.
- Provide oversight and financial assistants to support homeless outreach efforts at RCOs.

Funding Breakdown

Harbor Care currently manages a single contract, the Peer Recovery Support Service Facilitating Organization (PRSS FO) contract, with multiple funding streams including; SORII, Substance Abuse Prevention and Treatment Block Grant, Governor's Commission on Alcohol and Other Drugs, Opioid Abatement Trust Fund, and General Fund dollars. New funding received for FY2025 included program specific dollars to support Homeless Outreach efforts, opening of a new recovery center in Berlin, NH under White Horse Recovery, supporting a new center in Lebanon, criminal justice integration in central and seacoast areas, and youth and family support programming. The PRSS FO contract is overseen by the NH Department of Health and Human Service (DHHS), Bureau of Drug and Alcohol Services (BDAS) and currently provides funding to twenty- one RCCs. On average, PRSS FO funding supplements 45% of subcontracted RCO's annual operating budgets. *RCOs also have independent grants and funding revenues not managed by Harbor Care that help support their day-to-day operations and programming*.

 - Harbor Care facilitates an ethics committee that allows directors to seek feedback and work through ethical dilemmas with other RCOs as problems arise.
 - Harbor Care continues to provide Community of Practice trainings quarterly with Technical Assistance being provided by Growth Partners.

Standards of Excellence

The Council on Accreditation of Peer Recovery Support Services (CAPRSS), a program of Faces & Voices of Recovery, measures include four core areas of standards (Principles, People, Practices, Performance) and thirty domains that are assessed by the RCOs themselves and through a peer review process. The four core areas of standards in the CAPRSS accreditation process – Principles, People, Practices, and Performance – refer to the mission, vision, and code of ethics that a center follows; the participants served by the center and the community the

center is in; the way that the centers go about helping their participants and benefit the overall community; and the data showing that the centers are performing at the highest level – both through fiscal responsibility and overall outcomes for participants.

While eight of the subcontracted RCOs were originally accredited through the CAPRSS program, Harbor Care worked collaboratively with Growth Partners, BDAS Technical Assistance contractor and BDAS staff, to develop a process to ensure NH RCOs meet standards designed and developed by NH partners. Since its implementation, three subcontracted RCOs have been reviewed in the NH RCO Standards of Excellence program, and all centers are engaging in the preparation process with Harbor Care staff to ensure compliance.

There are twenty-eight NH RCO Standards of Excellence which are organized into six domains, they include:

I. Structure and Staffing

- a. The RCO structure supports its ability to achieve its vision and carry out its mission and core responsibilities.
- b. The RCO staffing supports its ability to achieve its vision and carry out its mission and core responsibilities.
- c. The RCO has developed sustainable partnerships with other organizations in its service area that enhance its ability to advance its vision, mission, and core values.
- d. The RCO uses effective processes to market peer recovery support services and encourage community members to support and participate in RCO programs.

II. Board of Directors

- a. BOD membership is representative of, and responsive to, local communities of recovery.
- b. The BOD has a defined structure and roles and responsibilities for members.
- c. BOD organizational policies and procedures are consistent with the principles of good governance.
- d. The BOD uses participatory processes with diverse recovery and other community members to solicit their input, engage them in strategic planning, and ensure cultural competency.

III. Assessment and Planning

- a. The RCO collects, analyzes, and uses valid and objective data to identify recovery support needs.
- b. The RCO collects, analyzes, and uses valid and objective data to plan improvements to service delivery and access.
- c. The RCO uses participatory processes to engage partners and stakeholders—including those who are in, or seeking, recovery—in planning efforts.

IV. RCO Workforce

- a. The RCO provides policies and procedures to all staff and volunteers that outline requirements for the positions, rules of the center, and local and federal regulations.
- b. The RCO has a defined process for determining the number of staff and volunteers needed to provide effective programming.
- c. The RCO has defined roles and responsibilities for all staff and volunteers.
- d. The RCO has efficient and effective processes to recruit quality staff and volunteers.
- e. The RCO has efficient and effective processes to retain quality staff and volunteers.
- f. The RCO has a process for regularly providing reviews, feedback, and disciplinary measures to staff and volunteers.
- g. The RCO provides training opportunities for staff and volunteers that are relevant to their roles in the organization.

V. Operations

- a. The RCO has established defined operational policies and procedures for the staff and volunteers at the center.
- b. RCO operational policies and procedures are easily accessible to staff and volunteers.

- c. RCO operational policies and procedures are regularly reviewed and updated as needed.
- d. The RCO has the financial resources in place to provide necessary recovery supports and programming.
- e. RCO services are responsive to the demographics and needs of those who are in, or seeking, recovery in the service area.

VI. Monitoring and Evaluation

- a. The RCO has internal financial controls and systems to follow accepted accounting principles and accurately track the time of staff and volunteers.
- b. RCO staff have effective processes for monitoring the quality with which recovery support service and programs are implemented.
- c. RCO staff have effective processes for analyzing and using monitoring and evaluation data to improve the quality with which recovery support service and programs are implemented.
- d. RCO staff accurately collect and report program data in accordance with all requirements.
- e. The RCO has procedures in place to analyze and use program data to evaluate the impact and effectiveness of recovery supports and services and plan to improve outcomes.

The NH Recovery Community Organization Standards of Excellence is a five-step process;

- Organizational Development: during this phase RCOs participate in regular one-on-one meetings with Harbor Care. During these meetings RCO staff are able to ask questions and submit all required policies, procedures, and other documentation that demonstrate adherence to the standards described above for initial review and feedback from Harbor Care staff.
- 2. **Desk Review**: All policies procedures, and other required documentation is sent to BDAS for review to assess if they meet standards.
- 3. **Site Visit:** Representative from BDAS conducts an in person visit to RCO location(s). During the site visit, the center staff, board members, volunteers, and some participants will be interviewed about organizational policies and procedures. This helps ensure the organizational documents provided have been communicated throughout the organization and are used in daily operations.
- 4. **Findings Report**: based on the information obtained in steps two and three, BDAS compiles a report with a summary of findings and recommendations.
- 5. **Reassessment**: based on the findings and recommendations provided, Harbor Care will work with the RCO to develop a custom work plan and support for improvement in preparation for their next review.

Back Office Support

This ensures that small grass root and non-profit organizations have the resources needed to operate. Medicaid Reimbursement

Subcontracted RCOs continue to rely on support from Harbor Care when it comes to billing Medicaid for reimbursable services. In FY25, Harbor Care staff updated and disbursed a Medicaid Billing Manual specifically detailing the services that are eligible for reimbursement from Medicaid for PRSS and the process(es) centers need to take to become eligible to receive those reimbursements. The billing manual also summarizes the relative He-W 513 SUD provider rules for subcontracted RCOs to reference as they each work towards eligibility for Medicaid reimbursement.

RCOs receive support from Harbor Care to apply for Medicaid IDs, contracting and credentialing with individual Managed Care Organizations (MCOs), establishing organization procedures to submit claims, and connection to a third-party biller to help process claims and distribute reimbursement. There are currently eight RCOs actively billing Medicaid, two use their own internal back office supports to submit and process claims and six of them utilize the third-party biller facilitated by Harbor Care. Subcontracted RCOs billing Medicaid received a total of \$ 690,425.24 in reimbursement from NH MCOs in FY25.

Sustainability

Each RCO has been successful in leveraging FO funds for service contracts and grants which expand their scope of work. A majority of subcontracted RCO's receive additional funding for a variety of programs including but not limited to recovery coaching in the emergency department, probation and parole relationships, Recovery Friendly Workplace initiatives, homeless outreach, etc. All RCO's are in close working relationships with their regional Doorways. However, most RCOs still face workforce capacity issues related to their expanded roles in their communities.

It is clear that Medicaid reimbursement alone is not a sustainable source of dollars for the RCOs due to low reimbursement rates and the additional administrative procedures and time needed to process and submit claims. RCOs continue to work diligently to diversify funding sources and build financial reserves to cover extended times between incurring costs and receiving reimbursements. In FY25 Harbor Care partnered with the National Peer Center for Excellence to conduct a three-part training series on sustainability planning for subcontracted RCOs. Six out of ten subcontracted RCOs have an active sustainability plan for their organization. Harbor Care will continue to support and aid subcontractors on this matter..

Data Collection

Data collected and summarized below comes from two sources; qualitative data from RCOs written reports and quantitative data collected in RecoveryLinkTM.

RecoveryLinkTM is a modern company with a mission to provide a suite of accessible and impactful recovery support tools designed to elevate collective impact. The platform "offers recovery community organizations, peer recovery support providers, and enterprise health systems a suite of digital tools platform designed to improve outcomes through systems transformation." (RecoveryLink, 2021). The cloud-based program offers a secure platform for recovery providers to record recovery data and outcomes.

Participant Demographics

Participant demographics include age, gender, race, ethnicity, sexual orientation, and veteran status. The tables below represent total demographic information for participants that received at least one peer recovery support service in fiscal year 2025. Of the 4.006 unique individuals served throughout the fiscal year, the primary demographic is 25-44-year-old, heterosexual, white, non-Hispanic, men who are not veterans.

Participant Services

PRSS as they are defined for purposes of potential Medicaid billing are exclusive to individual or group Recovery Coaching and continuous recovery monitoring (or telephone recovery support). However, PRSS as delivered by NH RCOs include a broad array of services, including police-assisted recovery response programs; housing and other basic needs assistance; treatment/health systems navigation; inter/intraorganizational group facilitation; homeless outreach; hospital and emergency department response; transportation; services delivered to family members; community outreach and education, adventure outings, naloxone training and distribution, syringe service programs, fentanyl test strip distribution, etc. RCOs utilize the various engagement types in RecoveryLink to record these different services including recovery planning sessions, brief check ins, referrals, contact logs, and activity logs. *In FY25 subcontracted RCOs provided 26,370 individual services and 11,989 activities with 159,540 people in attendance and 1,021,680 items distributed.* The following tables offer fiscal year totals for services provided subcontracted RCOs including intakes, recovery planning sessions, referrals, (successful) brief check ins, group sessions, and activity logs. *TLC Lebanon location is currently under contract with Harbor Care through the Facilitating Organization as of May 2025 and service numbers reflect this.

Participant Outcomes

The primary outcome data metric is collected using the Brief Assessment of Recovery Capital (BARC-10). The BARC-10 is an assessment of recovery capital measured on a scale from 10-60. Recovery Capital is the measure of internal and external assets that can be utilized by recoverees to initiate and sustain recovery (Cloud & Grandfield, 2008). The original Assessment of Recovery Capital (ARC) identified 10 primary domains (substance use and sobriety, global psychological health, global physical health, citizenship and community involvement, social support, meaningful activities, housing and safety, risk-taking, coping and life functioning, and recovery experience) across 50 questions (Groshkova, Best & White, 2013). The BARC-10 was derived from the initial ARC tool to assess each domain for a total of 10 questions. This brief assessment tool is used to evaluate recovery support services and their effectiveness on recovery related outcomes, inform recovery support providers' service delivery, and provide a strength-based measurement of progress for the recoveree. It is recommended that this assessment be used at intake and a minimum of one month during ongoing service engagement.

All subcontracted RCOs consistently demonstrate increases in the average recovery capital of their participants when comparing baseline BARC-10 scores to their most recent BARC-10 scores. RCO's have a standard goal of completing a BARC-10 at least 30% of the time during ongoing engagements with participants. This benchmark completion rate goal was originally set to help increase the sample size (number of participants with two or more BARC-10s completed) to determine statistical significance. In support of these goals, Harbor Care provides ongoing technical assistance to the RCOs to help improve data monitoring and quality improvement efforts and also facilitates a forum for the RCOs to share what strategies have been successful or unsuccessful in this area.

Participants who received peer recovery support service(s) during fiscal year 2025 showed significant increase in Recovery Capital (M= 2.96, SD= 7.85) compared to baseline BARC-10 scores, t (12452) =41.99, p<0.01.

AFMC findings underscore that state-funded Peer Recovery Support Services (PRSS) delivered by Recovery Community Organizations (RCOs) are not only effective in increasing recovery capital but are also both cost-effective and cost-saving. A cost-effectiveness analysis model, developed by researchers at the University of Texas Health Science Center and Houston School of Public Health, demonstrates that PRSS significantly reduce healthcare costs by decreasing emergency department visits and hospitalizations. Compared to standard substance use disorder (SUD) treatment, PRSS save approximately \$5.47 million annually. The model also highlights broader societal savings, particularly in reduced criminal justice system costs. Long-term engagement with PRSS is associated with higher recovery rates and lower societal burdens. Regression analyses identified that increased participation in meetings, prosocial, educational, and advocacy activities—as well as progress on recovery plan goals—are key drivers of increased recovery capital. These findings reinforce the substantial value of PRSS as both an effective intervention and a fiscally responsible investment in public health.

PROGRAM UPDATES

Service Delivery

- Archways served 212 unique enrolled participants this quarter throughout various program offerings.
- A total of 803 successful sessions were logged, including 53 intake sessions for new comprehensive service participants, as well as 7 reactivation intakes for returning participants.
- Archways served 261 individuals not enrolled in programming through contact log sessions.
- Archways transportation program provided transportation to individuals from all four locations. The transportation program has proven invaluable as it has allowed participants to access healthcare, recovery supports, mental health supports, legal obligations, and other wellness supports.
- Archways continues to host parenting education classes for members of the community. Many community members who enroll exclusively in parenting classes also end up enrolling in full services, showing how important these classes are for the community.
- Archways continues to partner with HealthFirst, the Franklin area Federally Qualified Health Center (FQHC) to offer medically assisted treatment and recovery at Archways' Franklin location each Friday.
- Homeless Outreach continued this quarter with many distribution activities and assistance to the community. Archways logged 626 distribution activities this quarter with over 2400 items given out to the community including tents, sleeping bags, etc.

Quarter Highlights

- Archways was engaged to assist in recruitment efforts on behalf of the Recovery Friendly Workplace (RFW) initiative. Through collaborating with RFW and many local businesses, Archways was able to achieve target enrollments set by RFW, further expanding the reach of recovery friendly workplaces, reducing stigma, and strengthening communities.
- Archways focused intently on expanding its pro-social programming. Some of the
 greatest successes in this expansion have been youth and young adult jam sessions
 where participants can bring instruments (including their voice!) to gather and
 create music together, painting group nights, karaoke nights, and morning walking
 groups. These activities have allowed Archways to serve members of the
 community we may otherwise not have reached while strengthening our
 communities' recovery support networks. We have found participants of ALL ages
 have begun to attend (ages 6 to 80+!).
- Archways' legal system involved programming has continued to experience significant growth. At the close of year two of Archways' independent contract with SAMHSA on June 30th, 2025, enrollment in this program has more than doubled over year one of the contract. This program has proven to be an invaluable addition to the lives of members of the community who are re-entering or will soon be re-entering society from incarceration. Additionally, Archways has been able to help navigate the recovery needs of participants who have various levels of legal system involvement such as probation or parole, recent arrests, and in pending charge situations. Archways is also pleased to report that the minimum GPRA requirements under this contract, including a six month follow up target rate of 80% are being exceeded! The representative from SAMHSA under this contract has expressed much gratitude for these efforts, and has called our performance exceptional.
- In addition to the successes currently experienced in Archways' legal system involved programming, planning is currently underway to incorporate a pilot of our Family Threads program within the Family Connections Center of the Dept. of Corrections. Archways will provide training to corrections staff on the delivery of this groundbreaking, newly evidence-based program which incorporates Family

	Support and Strengthening with Peer Recovery Support services to accomplish a whole-person and whole-family approach to services for participants reentering the community. Archways is honored to collaborate with the Department of Corrections on this important initiative and deeply appreciates the support and encouragement of the advisory council at the women's facility, which played a key role in guiding us through the program's development and launch. • Archways' Youth Programming has continued to experience growth this quarter and year. Building on its presence in several high schools and middle schools, Archways has expanded its efforts to include collegiate recovery initiatives. • Archways has begun hosting multiple pro-social groups including meditation, art and painting, karaoke, and music jam nights. Some feedback we have received is that these groups are a very welcome addition to the collegiate communities as well as to the recovery community at large. In addition to this, Archways' collegiate program coordinator attended the Association for Alternative Peer Groups (APG) annual conference in New Orleans this June which focused on APG and other services provided to youth. Archways' collegiate programming coordinator and a member of management were invited to present on the topic of braiding resources to create a continuum of substance use and recovery support for youth. They were also able to bring some valuable information and practices back to New Hampshire to help improve youth services.
Challenges	 Housing insecurity in New Hampshire continues to be a major concern. Apartment rental costs continue to rise while more people need affordable housing. In addition to affordable rental homes, participants are being affected by lack of funding support from Doorway or Community Housing Program (CHP) due to certain certification requirements placed on the recovery home, not the resident. This reduces the number of overall recovery home beds available for people just starting out their recovery who typically do not have means to pay for the bed until they find stable work. It also puts participants at risk of losing recovery housing they had found if unable to pay. Participants are currently at greater risk than ever of losing their public health insurance coverage and Supplemental Nutrition Assistance Program (SNAP) benefits. While social service agencies can prepare to help mitigate the impact where possible, the reality is that many members of our communities will be affected by these changes, resulting in additional hardship.

Service Delivery ARCNH staff facilitated 435 individual sessions with participants from April 1st to Held 144 mutual aid and recovery and family support meetings serving 1,898 people, increased active participants to 73 and attended 35 outreach meetings. ARCNH had 162 walk-ins. Continued to develop family support services with corresponding increase in attendance by 30%. Began review of staff and volunteer training needs to streamline training programs and ensure high quality content and facilitation. RecoveryLink training help for all ARCNH staff members and volunteers. **Quarter Highlights** The average length of participant engagement is 271 days (~8.5 months) and participant Basic Assessment of Recovery Capital (BARC10) reflect statistically significant improvements in recovery capital and quality of life outcomes. ARCNH also held three Stronger Together Veterans Coalition (STVC) monthly meetings from during the first two quarters of 2025. ARCNH is the only recovery community organization that includes a veterans' coalition in New Hampshire. STVC is holding its first annual Motorcycle Ride and Rally on 7/27 which will begin with a tour of the Easterseals Veterans' Campus in Franklin, NH. We conducted over 35 outreach meetings and are on track to increase the number of new participants to 50. ARCNH also held a number of pro-social events including Sober Super Bowl, Paint Night, Tie Dye, Origami, Dungeons and Dragons for participants, family members, and loved ones and a Sound Bowl for Healing, a meditation event for veterans during the April through May of 2025. We also conducted a two-day leadership training for all staff members and volunteers by Michael King from The Communities Project on 4/30 and 5/1/2025. All ARCNH staff members and volunteers were re-certificated in naloxone (Narcan) administration by the New Hampshire Harm Reduction Coalition in March 2025. ARCNH's Executive Director attended six monthly New Center for Nonprofits CEO Roundtable meetings. ARCNH was featured in a WMUR segment (New Hampshire ABC affiliate) on SUD and homelessness in the greater Manchester area. ARCNH participated in a University of New Hampshire senior business class marketing project for the 2025 spring semester which produced an actionable and thoroughly researched marketing report. ARCNH's Executive Director attended three Nashua Mayor's Task Force on Substance Misuse meetings STVC participated in the NH Department of Military Affairs and Veterans Services' 2025 Ask the Question and Ending Veterans' Homelessness Summit conferences in April and June. ARCNH's Executive Director attended five monthly Community Action for Safe Teens (C.A.S.T.) coalition meetings including one in which ARCNH conducted naloxone training. ARCNH has continued work on its Standard of Excellence (SOE) accreditation with Harbor Care. ARCNH's four recovery coaches and Executive Director attended the R.I.C.H. conference on 4/16 and 4/17. Challenges Raising awareness of the Addiction Recovery Coalition of New Hampshire (ARCNH) remains essential, as many community members are still unaware of the services offered—including that they are provided at no cost. Additionally, stigma continues to be a significant barrier preventing individuals from seeking treatment and support. Sourcing sustainable funding is a challenge. ARCNH is working to identify

The funding has allowed us to be more consistent with having supplies available and being able to offer additional support to peers with housing insecurity. PROGRAM UPDATES

PRSS: The primary service we offer to participants is one-on-one peer supports, either in person, over the phone, or via Zoom. PRSS includes brief check-ins, follow-up engagements, helping participants achieve goals set in their recovery wellness plans, and providing case management/system navigation. Homeless/Street Outreach: Three days a week, the coaches go out in pairs to provide street outreach to people experiencing housing insecurity and homelessness. Coaches offer treatment and recovery resources, hand out tents, blankets, socks, naloxone, personal hygiene products, etc., and provide PPE, rapid COVID tests, and vaccine information. This quarter we spent \$4,352 on food for unhoused community members and served 636 people.

- Compass House: We continue to provide weekly house meetings and one-on-one coaching to the 8 women at Compass House.
- CORE Groups: Weekly group meetings are held at Belknap County Corrections for the Correctional Opportunity for Recovery and Education Program residents.
- 24/7 Hospital Support: This quarter we saw 80 patients in the hospital and referred patients to withdrawal management, treatment (all levels of care), sober living, group meetings, The Doorway, and peer support services.
- Parenting Journey in Recovery: Weeks 3-10 were held this quarter.
- LEX (Laconia Exchange): This quarter, we collected 25,569 syringes and distributed 25,982 (98% return rate). We also distributed 1,138 safer smoking kits. In addition to the safer use kits, we also distribute wound care kits, Xylazine test strips, Fentanyl test strips, condoms, HIV at-home test kits, Plan B, O-Pill, and other essential items.
- Youth Coaching: "Building Futures Together" trained coaches run groups at Belmont High School and Inter-Lakes Middle/High School, and provide one-on-one coaching to participants 12+. This quarter we held 16 youth groups with 47 attendees.

Quarter Highlights

- Our Saturday bagged lunch program distributed 3,014 lunches and protein or yogurt drinks this quarter.
- After a few years of working towards his goal, a male participant got a full set of dentures and has a full bright smile again.
- Youth male participant got his Hi-Set, graduating a year early, and completed his Drivers Education classes
- Male participant celebrated 4 months of recovery, first time in his life. He also completed PJR and has visitation with his son again. Recently had him overnight for the first time in 5 months for four days straight.
- A chronically unhoused male participant completed residential treatment and is now in sober living.
- Youth participant finished Junior year on honor roll and has found part-time employment for the summer.
- Male participant completed some master's level college courses for his degree in clinical mental health and got married.
- Male participant, who has been unhoused for 6 years, got an apartment with wraparound services through the Concord Coalition to End Homelessness.
- Male participant advanced to become the house manager for his sober living, getting the benefit of not paying housing fees anymore and giving back to his community.
- Male participant has obtained funding for his Impaired Driver Care Management Program (IDCMP) class in full from Workforce Outfitting and is enrolled. He also moved out of living with his mother and got his own place.
- Male participant received dentures with support from the NH Dental Society.
- Male participant awarded supervised visits with his daughter. Recently celebrated 1 year of recovery.
- Female participant obtained new apartment and recently got raise at full time job; reconnected with grandchild.
- Female participant celebrated 2 years of recovery, recently got a new full-time job and is visiting family out of state for the first time in over 5 years.
- Female participant started her dental journey and had her consult and extractions done. On to the next step of the process for her!
- Female participant implemented healthy boundaries with family member. Retiring in mid-July, which she is very excited about!
- Female participant started seeing a mental health counselor. Utilizing local resources and just got her car fixed and registered.
- Female participant paid legal fines and got her driver's license back after not having it for years. She has supervised visits with son now and is working on trust and communication with son as well.
- Male participant recently reached 13 months of continuous recovery. He also just got the Assistant Manager position at his job.

	An 83-year old male participant's treatment of cancer is going well and he is maintaining his health. He also has not had any falls recently.
	 Male participant new to recovery went through inpatient, Partial Hospitalization Program (PHP), and Intensive Outpatient (IOP), is now in sober living. He is working full-time, thanks to Workforce Outfitting funds he used to purchase work clothes and he is taking his recovery very seriously.
	 Female participant paid off court and Dept. of Motor Vehicles (DMV) fines using Neighbors in Need funds and got her license. She also got a job and has moved out of sober living.
	• Female participant has regained guardianship of her daughter and is starting to get out to meetings and social activities to help her mental health.
	• Female participant is meeting her set goals weekly and is working on her self-care and confidence to get out of the house and participate in social activities.
	 Female participant was able to maintain her 8th yr. of sobriety, which was particularly difficult after her significant other, a "partner in crime" had a reoccurrence and overdosed. After completed referral participant is now working with LRMHC and will soon be starting counseling for herself and 7yr. old daughter.
Challenges	 As the treatment landscape in NH continues to shift towards PHP, we are finding it harder to place someone in residential treatment (if that is the appropriate level of care), especially if they have Medicare for insurance. Without funding assistance from The Doorways, anyone with Medicare must seek treatment outside of the state.

- Through our SAMHSA-funded initiative, we provided employment transportation support to 19 individuals, distributing a total of \$5,190. Additionally, we assisted 10 individuals with recovery residence rental payments—totaling \$16,451.50—while they participated in weekly Peer Recovery Support Services (PRSS), thereby helping to stabilize their housing. Between July 1, 2024, and June 30, 2025, we invested nearly \$60,000 in recovery residence funding and approximately \$17,000 in employment transportation services.
- Our New Hampshire State Council on the Arts-funded experiential training program
 concluded in June, marking the completion of a yearlong collaborative initiative with
 the New Hampshire Theatre Project. The program was designed to enhance staff

In partnership with Dartmouth Hitchcock Hospital, we host bi-monthly Hepatitis C and HIV testing events at both of our TLC locations.

PROGRAM UPDATES

Service Delivery

Services Provided Unique to TLC Recovery Programs:

- TLC's individual recovery support services provide personalized, one-on-one assistance to individuals in recovery from substance use disorders, mental health challenges, or co-occurring conditions. These supports are delivered by trained recovery specialists, including peer recovery coaches with lived experience, and are tailored to meet each participant's unique goals and stage of recovery. Services may include emotional support, goal setting, relapse prevention planning, and help accessing housing, employment, education, healthcare, and other essential resources. Through a compassionate and person-centered approach, TLC empowers individuals to build resilience, strengthen recovery, and achieve long-term stability and wellness.
- Collaborative Outpatient Services: This program is designed to support individuals in
 establishing strong foundations for sustainable, long-term recovery from substance
 misuse and addiction-related issues. Through this three-month program, engaged
 participants will build their social capital with group support, counseling, and recovery
 coaching during the initial stages of their recovery process.
- Mapping our Recovery: The purpose of the Recovery Journey Plan program is to provide individuals recovering from substance use disorders with a structured, supportive environment that fosters personal growth, self-awareness, and accountability. Through a series of sessions focused on storytelling, values exploration, self-care, and support systems, participants engage in meaningful discussions and activities that empower them to create personalized recovery plans. The program emphasizes the importance of community, allowing individuals to connect with others who share similar experiences and challenges, thereby reinforcing the notion that recovery is a shared journey. Ultimately, the program aims to equip participants with the tools and strategies they need to navigate their recovery successfully, promoting resilience, hope, and lasting change.
- Recovery Reflections Group: This group aims to facilitate a deeper understanding of how personal values and principles shape our lives, particularly in the context of

- recovery from substance use. By exploring these foundational elements, participants can better align their decisions and behaviors with their core beliefs, leading to healthier and more fulfilling lives. The group encourages open sharing in a respectful and supportive environment, allowing individuals to reflect on their feelings, experiences, and insights. Through structured discussions and check-in questions, members can actively engage in self-reflection, express gratitude, and identify goals, all while reinforcing community connections. The overall purpose of the program is to empower individuals in their recovery journey by promoting self-awareness, accountability, and personal growth.
- Recovery Engagement Incentive Program (REI): This program is designed to enhance participant retention and motivation in recovery-based services, particularly during the critical initial two months of engagement. Recognizing that many individuals struggle with maintaining motivation after their initial commitment to recovery, this program seeks to address that challenge by providing tangible incentives for continued engagement in recovery support activities. The REI Program targets new participants and includes structured guidelines for enrollment and eligibility, focusing on individual recovery support and staff-led groups. Participants can earn Walmart gift cards as they complete various recovery engagements, thereby reinforcing their commitment and involvement in the recovery process. The program also emphasizes accountability through documentation and tracking of attendance and participation. By offering financial incentives, the REI Program aims to encourage consistent attendance at recovery planning sessions and support groups, ultimately fostering a supportive community that aids participants in their recovery journeys. This structured approach not only promotes engagement but also seeks to improve overall recovery outcomes, helping individuals sustain their motivation and commitment to lasting change.
- Financial Assistance Program: This program offers short-term financial support and emergency funding for individuals impacted by substance use disorder, seeking to eliminate financial barriers to essential recovery services. Eligible participants can use the funding for various needs, including treatment costs, transportation, legal fees, medical expenses, and any other barriers to sustained recovery. This program is committed to helping individuals access critical resources on their path to recovery.
- Resource Navigation Program: This program provides Resource Navigation Specialists
 at each location, available during drop-in hours without the need for an appointment.
 They offer resource navigation, case management, and immediate support for any
 other needs that may arise.

Other General RCO Programs:

- Workforce Outfitting Program: This program leverages existing New Hampshire
 Healthy Families funding to support workforce participation by supplying essential
 materials for individuals starting their employment journeys. By facilitating access to
 necessary items, the program aims to enhance job readiness and promote sustained
 employment.
- Street Outreach: This program is a crucial component of a comprehensive approach to addressing substance misuse for our unhoused population. It fosters trust, provides immediate resources, supports harm reduction, and connects individuals to necessary treatment and support systems. Staff venture into homeless encampments, soup kitchens, and warming shelters to build relationships, provide needed materials, and share about our services. For this reporting period, 11% of our referrals for individual recovery support were a result of connections built through this service.
- TLC also provides Telephone Recovery Support and Parenting Journey in Recovery through our subcontract with Harbor Care.
- All RCO programs have been going strong with consistent referrals and attendance.
- TLC's staff facilitated groups and outside group partnerships have maintained consistent attendance.
- TLC has multiple contracts and MOUs to support other organizations, communities, and programs with peer recovery support. They include Family Treatment Court, Sullivan County DOC, Probation and Parole, Valley Regional Hospital, DHMC Doorway,

	Headrest, Hope for Freedom Recovery Homes, Sullivan House, the City of Claremont,
	Better Life Partners, and Groups/Recovery Together.
Quarter Highlights	 TLC engaged 277 participants in individual recovery support, completed 61 intakes, conducted 925 hours of brief check-ins and recovery planning sessions, and hosted a total of 97 hours of staff-facilitated group sessions. On average, participants' recovery capital has increased, indicating that the support and services we provide are effective and having a positive impact on their recovery journey. TLC's new location in Lebanon has seen great success. We have been consistently receiving referrals, building new partnerships with local organizations, hosting events, facilitating groups, and providing recovery support services to many individuals. TLC has recently finalized its contract with Harbor Care to formally include the Lebanon RCO. Across both RCO locations, TLC now offers a total of 10 staff-facilitated groups per week and our locations host a total of 8 outside groups per week. These groups support various recovery pathways and have maintained consistent attendance.
	 Upon completion of the RFW contract with Granite United Way, TLC secured 22 letters of intent (LOI) from businesses seeking to become RFWs. This achievement means TLC has far exceeded its goal of 10 LOIs for this contract period.
	• TLC hosted several impactful events aimed at supporting the community and promoting wellness. We collaborated with the DHMC HPV Program to hold three Point of Contact sessions, offering free HIV and Hepatitis C testing to community members. In addition, we organized three recovery-focused events: Dance of the Decades, the For-U Summer Event, and Men's Mental Health Awareness. At Dance of the Decades, attendees dressed in fun, era-themed costumes and enjoyed a lively evening featuring a catered dinner, dancing, and lots of laughter. The For-U Summer Event treated participants to a relaxed day out in Lebanon, including mini-golf and ice cream. For the Men's Mental Health Awareness event, guest speakers shared insights on mental health, followed by a group discussion and light refreshments. All events were well-attended and warmly received, helping to foster stronger connections within the recovery community.
	 We have enhanced our contract with the Sullivan County DOC by providing two staff-facilitated recovery groups and providing more recovery coaching within the DOC. TLC is working on a contract with West Central Behavioral Health to embed two part-
	time CRSWs into their Claremont and Lebanon programs.
Challenges	 TLC is hoping to complete its Standards of Excellence Accreditation soon. Our organization is prepared and awaiting the state's next steps in moving the accreditation process forward. Achieving accreditation will enhance our funding opportunities and open doors for additional resources once it's granted. TLC continues to monitor both federal and state policy changes to ensure it makes informed decisions that best serve its community, regardless of shifts in government regulations.
